



COMPUBET

BONUSES, REWARDS, AND MEMBER BENEFITS:

Please refer to our Terms & Conditions of service which you must agree with in its entirety in order to utilize the services of CompuBet, and participate in the Rewards and Member Benefits provided by CompuBet.

Additionally, you must recognize and agree that CompuBet at any time at its sole discretion may cancel or change any or all of the member benefits described herein, and members are advised to review this document on a regular basis. While we make every effort to notify customers via email of any significant changes, this document is and will remain the official Terms & Conditions of all Member Benefits, as outlined below:

SIGN-UP BONUS**

You must first fund your account with \$50 or more

You cannot draw down the account below \$50 until you have wagered at least \$500 (our bonuses are intended to help you get familiar with our site, and get a head start on wagering, not to use for withdrawal)

Only one sign-up bonus will be paid to any one household, family, IP address, etc., until it has been verified after several weeks or possibly months at our discretion that both are legitimate active accounts! This will also include any other situation at our sole discretion.

Subject to compliance with the above conditions, and after your initial deposit has been verified, cleared, and added to your account, we will within 48 hours credit you with an additional \$50!

** CompuBet reserves the right to limit the sign-up bonus to one player per family, household, or IP address, or restrict in any way when deemed necessary to protect the interests of all of our players. CompuBet reserves the right to withhold any rewards/bonus payment if it believes the promotion has been abused and/or where the terms of the offer are not fulfilled, or any irregular betting patterns are found. The decision of the CompuBet management is final. CompuBet reserves the right to withdraw or amend the offer at any time, for any reason and without prior notice. It is the customer's responsibility to check if it's legal to bet in their state.

CompuBet Rewards Program Terms and Conditions

CompuBet offers a two-level Rewards Program. Rewards are based on track and wager type. Some tracks do not allow us to pay rewards, and some wagers are excluded from rewards at CompuBet's sole discretion. Account holders must be in good standing with no outstanding fees or penalties to participate in the Rewards Program.

ELIGIBILITY

Active CompuBet account holders in good standing are automatically enrolled in the CompuBet Rewards Program. Continued membership in the Program is subject to continued compliance in all respects with these Terms and Conditions as well as all of the terms and conditions applicable to the Member's CompuBet wagering account. Any violation by the Member of these Terms and Conditions or of the terms and conditions applicable to the Member's CompuBet wagering account as determined by CompuBet in its sole discretion may result in termination of the member's participation in the Rewards Program, and any rewards accrued but unpaid may be denied.

EARNING REWARDS

A. Rewards credits will accrue each time a Member places an Eligible Wager via the Site. In addition, from time to time special offers may provide additional opportunities to earn Rewards. Details will be provided when each such offer is presented.

B. Player Rewards are added DAILY to your wager account (varies by wager type* and track)

We have a two-level Player Reward structure. Players who have wagered at least \$1,000 the previous month receive PREMIUM REWARDS for the current month**.

The basic rewards (Silver) range between .5% and 6%

Premium (Gold) rewards range between 1% and 7%, but generally 2% higher than basic rewards.

Some tracks do not allow us to give rewards, and some tracks charge us very high host track fees. We have designed a rewards structure that conforms to our host track's regulations and still maximizes your member rewards.

If you would like information on rewards for a specific track, please contact us at customerservice@compubet.com. As a courtesy to our host tracks we cannot publish a "rewards chart".

*Straight bets include Win, Place, Show, and horizontal bets such as Daily Doubles and Pick 3's.

** CompuBet reserves the right to reduce any player's rewards status to the basic "SILVER" level at any time for reasons that it deems appropriate.

Race Information and Handicapping:

Programs

Level one (Silver) players are entitled to two PPs (\$2.50 or less) as long as they wager at least \$10 on each card. Advance day programs are excluded!

Level two (Gold) players are entitled to four PPs (\$2.50 or less) as long as they wager at least \$10 on each card. Advance programs are excluded!

Best Bets are free to anyone that bets at least \$5 on the day (harness), \$10 on Thoroughbreds

Harness CB Reports are free as long as the player wagers at least \$25 on that particular card.

Thoroughbred CB Reports are free as long as they player wagers at least \$50 on that particular card.

Programs & CompuBet

Players may get both a PP and CB Report for a particular track, but the requirements of wagers will be added. In other words one free PP, plus one free harness CB Report would require a total wager of at least \$35

Other Handicapping Products

Many other products are available for purchase on our handicapper's store. Your wager account will be charged for these purchases.

EXPIRATION AND INACTIVITY

Rewards are intended for wagering use. Rewards credited to an account that has been depleted or drawn down to zero balance will not be available for withdrawal. Un-wagered Rewards will remain in the player's account for future use, however for a period not to exceed three (3) months after the most recent wagering activity. You as the account holder acknowledge that the wagering platform services provided by CompuBet, including video streaming, race replays, and results, are for active wagering customers. Any account that is inactive for a period of three (3) months will be suspended from such services.

PROGRAM MODIFICATION OR TERMINATION

CompuBet reserves the right at any time, without notice, to add, remove and/or change or otherwise modify any feature of the Service, Rewards, or these Terms and Conditions. CompuBet further reserves the right to terminate the Rewards Program at any time, without prior notice, restriction or penalty.

MISCELLANEOUS

- A.** Rewards may not be assigned, sold or otherwise transferred by the Member, by operation of law or otherwise.
- B.** The Rewards Program is subject to all applicable laws and regulations and is void where prohibited by law.
- C.** The accrual of Rewards may subject a Member to income or other taxes. The Member is solely responsible for determining the extent of any tax liability for any federal, state or local taxes as may be applicable, and any disclosure related thereto or payment thereof
- D.** By participating in the Rewards Program, Members consent to and authorize CompuBet to share information about the Member in accordance with the terms of the CompuBet Privacy Policy Statement (see Privacy Policy section below).
- E.** All interpretations of these Terms and Conditions, as well as questions or disputes regarding continued eligibility for the Rewards Program or the availability of or entitlement to any Rewards, Rebates or Bonuses, shall be resolved by CompuBet in its sole discretion.
- F.** These Terms and Conditions shall be construed in accordance with the laws of the States of Oregon and Maine (depending upon the services received) without reference to the conflicts of laws provisions thereof. These Terms and Conditions constitute the entire understanding between CompuBet and Customer with respect to the Service, and supersede any and all prior communications, whether written or oral, and all previous versions of terms and conditions

applicable to the Program.

CompuBet Wager Cancellation Policy

Cancellation of wagers will only be available prior to betting being closed for a given race. Cancellation of wagers is at the discretion of the host track, and CompuBet.com is not responsible for wagers that are not approved for cancellation. Excessive cancellation of wagers or any attempt to manipulate the odds of the race may cause your account to be restricted from having the ability to cancel wagers and or may result in your account being closed. Determination as to what is excessive and whether or not manipulation of odds is being attempted is at the sole discretion of CompuBet.

PRIVACY POLICY

For the privacy and protection of account holders, CompuBet nor eBet Technologies, will not disclose any information regarding an account holder's betting activity unless required by law.

By law, each account holder must immediately notify CompuBet of a change in the state of residency by calling 1-877-782-9994. If an account holder moves to a state where State of Oregon State or Federal law prohibits wagering activity for any reason, CompuBet is required to terminate the account and return all remaining funds.

CompuBet accounts are for the personal use of the registered individual account holder only and are not transferable. CompuBet reserves the right to void any wager if there is reason to believe that someone other than the registered account holder placed a wager on via the CompuBet wagering system.

In order to protect your account from unauthorized access, repeated attempts to access an account with an incorrect PIN or account number will result in your account being locked. To unlock your account you will need to contact the business office at 1-877-782-9994 who will ask you a series of questions including your Password to verify your identity. For your protection, do not disclose your PIN to anyone.

All CompuBet telephone conversations and transactions are recorded and confidentially stored to protect the customer and you as the account holder express your approval for CompuBet to record all conversations made to and from the call center and/or business office. CompuBet will resolve disputes, whether account or betting related, after a review of any recorded conversations and any record generated by CompuBet, eBet Technologies and AmTote wagering systems. If the account holder is not satisfied with the determination of CompuBet, the account holder may contact the Oregon Racing Commission (Telephone 1-971-673-0207).

Referral Program

A. For purposes of the CompuBet Referral Program, the registered user at this website who desires to refer friends to this website is referred to as the Sponsor. The person who is referred by a Sponsor is referred to as the Recruit. A Sponsor cannot refer themselves, their family or household members to join as a Recruit. This applies to any new accounts you may set up for yourself or on your behalf.

B. To qualify for the Referral Program, the Sponsor must be a registered user of this website with an Active status. Active status as it relates to the Referral Program means that the user's identity and age have been authenticated, that they have made a deposit to their wagering

account at this website, and that no deposits have been returned as uncollected.

C. If you are the Sponsor, you will be paid reward credits (dollars) based on the wagering of the your Recruit if : (1) they name you as their Sponsor at the time they sign up, (2) their age and identity are authenticated, (3) they make a deposit to their wagering account at this website, (4) they make at least \$50 in racing wagers within their first 30 days of joining this website, and (5) have no deposits which have been returned as uncollected.

D. The Recruit must be a new user to this website, not having previously registered any account at this website. The Recruit must declare the Sponsor at the time they register their account.

E. There is no limit to the number of friends a Sponsor can refer. All Recruits must be people the Sponsor actually knows, spamming or other mass marketing will not be tolerated and will result in the Sponsor's disqualification from the Referral Program, will result in no payment being made to the Sponsor under the Referral Program, and may result in the closure of the Sponsor's wagering account at this website.

F. All Referral rewards and bonuses are made in the form of credits to the Sponsor's wagering account at this website. No Referral rewards are paid on winning wagers which would pay \$2.10 for a \$2.00 wager. Referral rewards will be credited to the Sponsor's wagering account at this website within the first five days of each month based on the amount of wagering by qualified Recruit for the preceding month.

G. By agreeing to participate in the Referral Program, the Sponsor and the Recruit agree to allow disclosure of their wagering data to their counterpart as CompuBet deems appropriate.

H. This website reserves the right, in its absolute discretion, to exclude any Current User from the Rewards Program for any reason whatsoever without explanation.

I. This website may at any time suspend or void the Referral Program for any reason that, in its absolute discretion, thinks appropriate and any liability from this website to a Sponsor shall immediately cease upon a Sponsor being informed of this action, whether directly or by posting on the CompuBet website

MODIFICATION OR DISCONTINUANCE OF SERVICE

CompuBet may, in its sole discretion, modify, alter or discontinue the Service or limit, terminate or suspend Account Holder use of the Account as per the following rules and regulations:

ORC Rule 462-210-0030, Section 9: The account wagering center may close or refuse to open an account for what it deems good and sufficient reason, and shall order an account closed if it is determined that the information that was used to open an account was false, or that the account has been used in violation of these rules.

All CompuBet's account wagering rules, policies, terms, conditions and procedures are subject to change by CompuBet at any time. It is the account holder's responsibility to be aware of all
